

# **RULES OF THE COMPETITION BY DRAWING LOTS**

## **Next Shot Form - T-Fight RS**

### **Article 1 - Definition and conditions of the competition**

The company, Tecnofibre, registered in the PARIS Trade and Companies Register under number B 315 765 651, which has its registered office at ZI de la Briquetterie RD 307, 78 810 Feucherolles, is organizing a contest from August 2020, the 31<sup>st</sup> to September 2020, the 30<sup>th</sup>, a free game with no obligation to purchase entitled: "Instagram Contest - T-Fight RS (hereinafter referred to as "the Contest"), according to the terms and conditions described in these rules.

- The company Tecnofibre is also referred to hereinafter as: "the Organizer, the Organizing Company, the Organizers, the Professional".

- The "Participant" in the contest is also referred to hereinafter as "the Participant, the User, the Contributor, the Player".

- The "Winner" of the prize draw is also referred to hereinafter as the "Winner".

### **Article 2 - Conditions of participation**

This free contest is open to any natural person over the age of 18 with internet access and a valid email address, with the exception of the staff of the organizing company and their families, as well as any person who has participated in the development of the game.

The game is subject to the regulations of French law applicable to games and competitions.

Any participant who is a minor must nevertheless obtain the prior authorization of one of his/her parents or legal guardian to take part in the contest.

The organizing company may ask any minor participant to provide proof of this authorization and, where applicable, disqualify a participant who cannot provide proof of such authorization.

The Organizing Company may ask any winner who is a minor to provide proof of such authorization to participate in the contest. The organizing company reserves the right to draw another winner at random if an initial winner, if a minor, is unable to provide sufficient proof of said authorization.

The mere fact of taking part in this contest implies the pure and simple acceptance, without reservation, of these rules.

### **Article 3 - Contest dates**

- Contest start date: August 2020, the 24<sup>th</sup>

- Contest end date: October 2020, the 30<sup>th</sup>

- Date of draw: November 2020, the 2<sup>nd</sup>

- Date of designation of the Winner: November 2020, the 2<sup>nd</sup>

### **Article 4 - Terms and conditions of participation**

#### ***4.1) Conditions for submitting an application***

In order for the participation to be validated by the Organizer, there are steps that must be respected; the Participant must:

b) Fill in the form and register with an email address on the <http://www.nextshot.tecnifibre.com/> website by clicking on the validation buttons of the different steps

#### ***4.2) Guarantees and responsibility for the validity of applications***

Tecnifibre reserves the right to cancel, terminate or modify this operation if it does not proceed as agreed. Any virus, bug, violation, unauthorized intervention, fraud, competitor action, technical problem or other cause beyond Tecnifibre's control alters and affects the administration, security, fairness, integrity, or conduct of Tecnifibre.

In general, the Participants indemnify the Organizers of this contest against any recourse, action or claim that may be brought by any third party in respect of all warranties and commitments made.

Only one entry per person - same surname, first name, email address or Facebook ID - is permitted during the entire period of the contest.

Any incomplete or erroneous entry will be rejected, without the Organizer being held liable. Any untruthful declaration by a participant will result in his/her exclusion from the contest without the Organizer's liability being engaged.

Thus, the Organizing Company reserves the unreserved right to moderate a posteriori and not to validate, or even exclude or remove from the contest, any participant who does not comply with any of the conditions of these rules.

#### ***4.3) Methods of drawing lots***

- A draw to determine the Winner.

#### **Article 5 - Endowments/lots**

The game has the following prize, awarded to the valid participant drawn at random and declared a winner.

- A T-Fight RS tennis racket with a unit value of 300€ (incl. VAT)

The organizing company reserves the right to verify the age of any winner before awarding the prize. Prizes may under no circumstances be exchanged for their cash value or for any other prize. The organizing company shall not be held liable for the use or non-use, or even trading, of the prizes by the winners. In case of force majeure, the organizing company reserves the right to replace the prize won by a prize of equivalent nature and value.

#### **Article 6 - Designation of winners**

The winner will be drawn at random within 2 days after the end of the game.

The winner will be contacted within 2 days following the draw, confirming the nature of the prize won and the terms and conditions to benefit from it. Any winner who does not give an answer within 2 days from the sending of notification of his or her prize will be deemed to forfeit it and the prize will be awarded to a new winner.

#### **Article 7 - Terms and conditions for awarding the prizes**

Only one endowment for a single individual.

The Winner will then be asked to provide his/her precise contact details: surname, first name, date of birth, address, town, postcode, country, telephone number, email address by email to: rgliscenstein@tecnifibre.com.

If the information provided by the participant is incomplete and/or does not allow him/her to be informed of his/her win, he/she will lose the status of Winner and will not be able to make any claim.

The Organizer cannot be held responsible in the case of technical difficulties with the electronic notification of the prize. Without communication of this information from the Winner within 8 days, it will lose its status of Winner.

The official and personalized notifications of the attribution of the prizes to the Winner with the description and modalities of withdrawal will be sent to them by return email to the email address they have indicated, including a copy of the message on the email box of the Professionals concerned.

### **Article 8 - Nominative and personal data**

The Players authorize in advance by the sole fact of their participation, that the Organizers freely use for advertising or promotional purposes whatever the medium, all personal information communicated on their behalf and on all media.

The personal data collected about you is mandatory and necessary for the processing of your participation in the contest. They are intended for the Organizers, or for subcontractors and/or service providers for management purposes.

In accordance with the regulations in force, the information collected is intended exclusively for the Organizers and will not be sold or transferred to third parties in any way whatsoever.

The information communicated by the participant is intended for the use of MY BEAUTIFUL DRESSING within the framework of the access to its service in accordance with the general conditions of sale and within the framework of the management of the present game.

### **Article 9 - Responsibilities and rights**

The Organizers:

- Reserve the right to modify, extend, shorten, limit the winnings or cancel this game in case of force majeure as defined by jurisprudence. Consequently, their liability cannot be engaged as a result.
- Cannot be held responsible for the fraudulent use of connection rights or attribution of a Participant's prize.
- Are not liable in the event of malfunctioning of the Internet network, telephone lines, reception equipment preventing the smooth running of the game. Furthermore, they may not be held liable for problems of delivery or loss of electronic or postal mail.
- Release any liability in the event of technical failure, anomaly, hardware and software of any kind (virus, bugs, etc.) caused on the Participant's system, their computer equipment and the data stored on it and the consequences that may result from this on their personal, professional or commercial activity.

### **Article 10 - Conditions of exclusion**
